1.0 INTRODUCTION.

1.1 Overview.

Public participation is a legal requirement which is anchored in the Constitution of Kenya 2010, Urban Areas and Cities (Amendment) Act 2019, County Government Act 2012 among other pieces of legislations. Urban Areas and Cities (Amendment) Act 2019 mandates the Board to ensure participation of the municipality residents in decision making in its activities, projects and programmes undertaken within its jurisdiction.

In compliance to the above legislations, Rongo Municipal Board organized a citizen forum on 12th September 2023 at Rongo Municipal Hall. The objective of the forum was to update the municipality residents on the completed and ongoing municipal projects, receiving views of the residents on the challenges they are facing within the municipality and their priority issues to be implemented by the municipal board in the next financial year.

1.2 Preliminaries.

The meeting was called to order at exactly 10: 05 am by the Board chairman Mr. Brighton O Angienda who then called Bishop Joel O Nyauche to offer a word of prayer. After the prayer, the Municipal Board Vice Chair Ms. Faith A Ooko, was called to do introductions and welcome the members in the municipality.

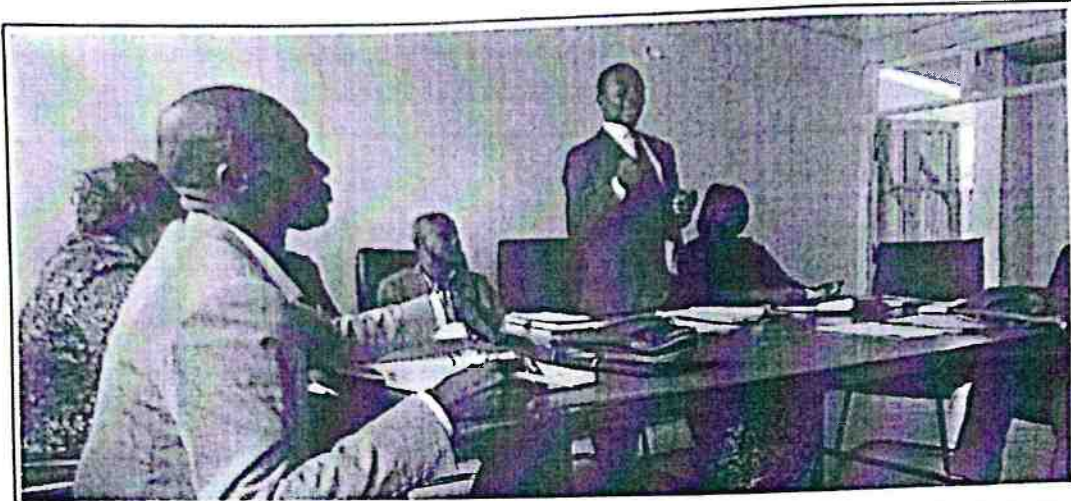
2.0 OVERVIEW OF THE MUNICIPAL MILESTONES AND PROGRAMMES.

After introduction of all the members present, the Municipal manager was then invited to update the municipal residents on the municipal milestones and give an overview of the completed and ongoing projects/programmes within the municipality.

The municipal manager began by giving an overview of the municipality, its establishment and operationalization. He further lauded the County Government of Migori for the great effort they have put in place to ensure creation and operationalization of the municipalities. In addition to the above, the manager brought to the attention of the municipal residents the development partners specifically the World Bank who have funded various infrastructural projects in its three Phases (I, II and III) of partnership within the municipality including but not limited to Construction of Rongo Township Roads, Construction of Rongo Bus park and Installation of Solar Powered Street Lights in Rongo Town, Rongo Municipality.

Finally, the manager informed the municipal residents of the ongoing projects of constructing a Non- Motorized Transport (NMT) facility along Las Jona – Posta – KCB – AI Road, Tamu Supermarket – Hospital – Police Station Road and Bearbelt – Posta Road. The NMT facilities once completed will improve the aesthetic image of the municipality and reduce case of pedestrian – vehicular conflict which has been a case before.

3.0 REMARKS FROM THE DEPUTY COUNTY COMMISSIONER.

After introduction of all the members present, the Municipal manager invited the Deputy County Commissioner -Rongo Subcounty, Mrs. Monica Ithania to give her remarks.

The deputy county commissioner began by appreciating the role the County Government, the County Assembly and the executive played in ensuring that the municipality was in place and promised to continue working together with the subcounty administration and the municipality for the benefit of Rongo municipality. She also stated the need for the municipal board to enact bylaws governing the municipality and its operations. In addition to the above, she stressed on improvement of security within Rongo municipality more so investment in street lighting to curb social and economic ills like theft and vandalism. He finally notified the residents that Corona is back and emphasized the needed of the residents to take caution and maintain hygiene and safety precautions wherever they are. The Municipal Board Vice Chair then invited the Subcounty Administrator, Rongo Subcounty to give his remarks.

4.0 REMARKS FROM THE SUBCOUNTY ADMINISTRATOR.

The Subcounty administrator began by welcoming all the members to Rongu Municipality and Rongu Subcounty at large. He appreciated the good working relationship between the municipality, county government and the national government with a common interest of serving the residents of Rongu. He further beseeched the municipal residents to give support to the municipality in implementing the development project within the subcounty.

In addition to the above, he also stated the efforts his office together with the area chief has done to ensure the roaming animals in town are managed.

Finally, the Subcounty administrator emphasized on the need to safeguard public land, opening up of all access roads including the current bus park – BAT – Riosir ring road and promised to follow up on the previous initiative of the development partners to provide piped water to residents of Rongu Municipality.

5.0 REMARKS FROM THE AREA MCA.

The Area Member of County Assembly of Central Kamagambo ward was then invited to give remarks to his voters. He began by appreciating the strides the municipality has made since inception as he was a member of the first municipal board of Rongu; 2017-2022.

He emphasized the need for the residents to be law abiding and be ambassadors in keeping law and order especially in safeguarding the environment, management and cleanliness. He also assured his commitments to the residents on engaging the BAT management for allocation for land to the municipal residents use as an industrial zone of the town.

In addition to the above, he pointed out the cases of land grabbing of public land within the municipality and discouraged the authorities against indiscriminate allocation of public lands and spaces. Finally, the Honorable member promised to give support to the municipality by legislating and pushing in passing resolutions and proposals geared at the betterment of the municipality and Rongu Subcounty at large.

After this presentation, the municipal residents were then invited to give their presentations in categories of:

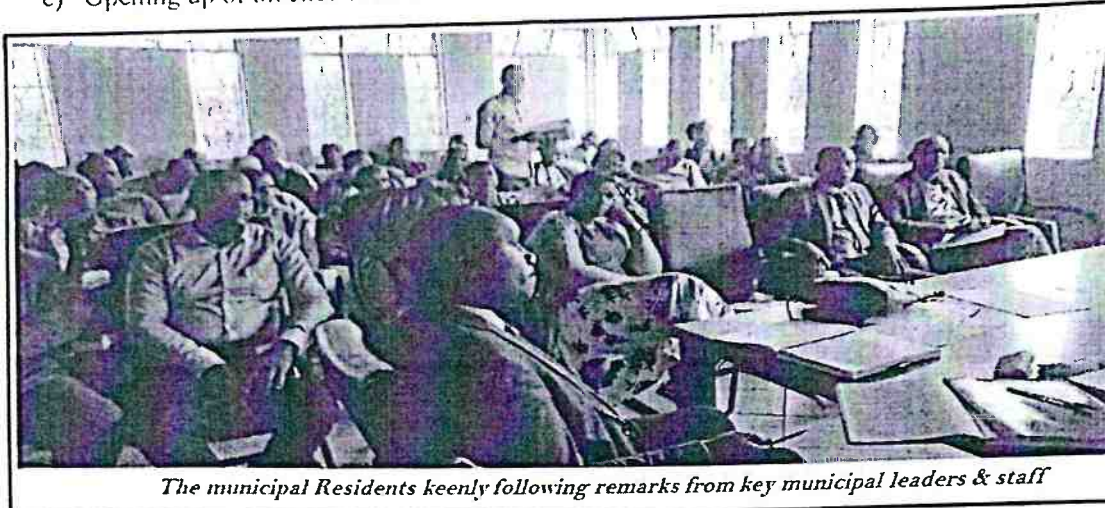
- a) Clean and healthy environment.

5.0 PRESENTATION FROM THE MUNICIPAL RESIDENTS.

5.1. Clean and Healthy Environment.

- a) Poor medical waste disposal mechanism. Medical facilities poorly disposing wastes within the municipality. I.e., Areas around Ladorpharma.
- b) Poor collection of solid wastes from the generation sites. The collection to the temporary sites takes so long.
- c) Lack of proper solid waste management mechanism in the bus park. The washroom in the bus park is not operational. The municipal management to pick up the matter with the contactor and ensure the ablution block is operational and the septic tank is drained.
- d) The management of solid waste in the backstreet is poor. The poor state of the backstreet is a main contributor to the moral decay within the street. Drug and substance abuse and cases of prostitution is evident.
- e) Proper installation of waste bins and their spatial distribution should be ensured to effectively and adequately collect wastes in the street.
- f) Proper storm water drainage to curb flooding within the CBD.
- g) The traders to have waste papers on their business premises to manage waste onsite. This will generally control existence of wastes everywhere and facilitate easier collection.
- h) Lack of proper liquid waste management system. The municipality lacks a conventional sewerage system for proper management of liquid waste. The municipality board and



management requested to partner with other development partners to actualize this costly investment

- i) Proper implementation of municipality bylaws regarding solid and liquid waste management.
- j) The cateries within the bus park and the old stage are poorly disposing their wastes. This generally compromises the general hygiene of such establishments.
- k) Proper street and town beautification process to be ensured. Ornamental trees to be planted and beautification programmes be undertaken. This will generally improve the general cleanliness and healthiness of that environment.
- l) Frequent dredging of storm water drainage channels within the municipality.

5.2. Public Transport Management. (Matatus, lorries, tractors, Taxi, Pickups, Bodaboda, Tippers and Bus Park)

- a) Proper installation of public shades and bodaboda shades to be ensured to enable order within the municipality.
- b) Indiscriminate taxation of the lorry and tipper owners plying intercounty routes. The rates of taxing the tippers and lorry owners within Migori County is punitive. A request was made to the authorities to intervene.

- c) The completion in construction of the Rongo Modern Bus Park to be ensured. This will enable full operationalization of the bus park.
- d) The exit of the bus park to be provided and opened. The bus park has no exit. The entrance acts as the exit as well. This is a recipe of chaos and congestions at the entrance of the bus park. The municipal manager together with the subcounty administrator are tasked to engage the county director of roads and public works to intervene and ensure this is realized. A proposal of seeking assistance from the Chinese contractor doing the A1 Road currently was preferred.
- e) The concrete pole at the entrance of the bus park be relocated to another favorable site. This is to avoid obstruction experienced at the entrance of the bus park.
- f) The power supply in the bus park was disconnected by then and most shops remained closed. This is because a good number of shops and operations of the bus park purely relies on power.
- g) Renovation of the Rongo modern market structured to be done. Most of the structures including stalls, shades and washrooms are dilapidated risking the lives of the vendors.
- h) Conflict in matatu and taxi parking. A request for provision of flush parking within the CBD of Rongo town be ensured. This will provide the additional and proper parking spaces for private vehicle across the municipality and the taxi operators.
- i) Enforcement officers to ensure that all the buses and matatus operate and park within the bus park. No picking or dropping of passengers on the highway.
- j) There was a proposal to tax the ploughing tractor operators who come from other counties during planting season. This was viewed as a good revenue stream.
- k) The tuck and tipper drivers requested to be engaged in municipal waste collection jobs.
- * l) BAT management to be consulted for establishment of an industrial areas in their site.

5.3. Reorganization of Kiosks, streets, vendors and hawkers.

- a) A proposal from the municipal residents was presented to provide for additional kiosk in open spaces within the bus park. This will provide for additional investments, business spaces, vibrancy of the bus park and general revenue collection.



- b) The municipal garage owner's representative requested for demarcation of designated parking spaces along the A1 highway to enable ease of servicing of broken vehicles on the highway before eventual towing to the respective garages.
- c) The faith-based community made a request to the municipal administration to allocate and plan for open spaces for relaxing, resting, team building and even for spiritual activities.
- d) It was brought to the attention of the municipal management that there are some government officers who are indiscriminately allocating spaces for illegal kiosks without professional opinions and consultations.
- e) A proposal was presented to have a plan/design for the municipal kiosks. This will enable order in arrangement of kiosks and improve the general outlook and beauty of the urban core.
- f) The residents requested the authorities to always issue notices before removal of illegal and temporary kiosks. This saves on the possible losses incurred during unplanned relocation.
- g) The business community were requested to be cooperative during the construction of A1 Road and other urban roads, to be flexible.
- h) The municipal management were requested to install proper and quality street lights with the municipality. It was realized that previously installed security lights were of low quality. This was realized as one of the possible reasons for vandalism.
- i) A request for provision of non-motorized means of transport for traffic segregation was presented. This was to curb passengers - vehicular conflict which leads to accidents.
- j) The allottees of the old stage requested to be included as the beneficiaries of the modern bus park.
- k) The municipal administration was tasked to investigate the complaints about the county officials allocating themselves open spaces for kiosks, failing to pay for the county dues and involving themselves in compromising urban order and arrangement.

5.4. Urban beautification.

- a) The municipal management were tasked with the responsibility of ensuring the urban core of the municipality has undergone facelifting and beautification. This was aimed to be met

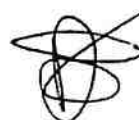
through planting of ornamental trees and flowers along major transit corridors and through painting of urban infrastructure and developments.

- b) There was a proposal to undertake various beautification programmes within the municipality like tree planting days.
- c) It was proposed that proper display and advertisement boards be erected to promote order and beauty of the streets.
- d) It was suggested that roaming animals in town should be confiscated and taken to Lichota farm as they interfere with the aesthetics and urban outlook.

5.5. Opening of blocked access roads.

- a) A request to open all the blocked access roads within the municipality was presented. This was aimed at ensuring proper accessibility and ease of reaching destinations whenever an emergency arises.
- b) A priority of opening and upgrading of the backstreet to be ensured. This is to manage the mess, pollution from dumping, moral and social decay from the evident cases of prostitution ongoing in this street.
- c) Pramuk – Nyaugenya – Mimosa Road to be upgraded. This exercise is aimed at opening up the zones along these routes.
- d) The technical officers in charge (Physical planner and surveyor) to undertake survey and demarcation of blocked access roads as per the approved Physical and Land use Plan of Rongo town.

6.0 PRIORITIZED PROJECTS TO BE IMPLEMENTED BY THE MUNICIPALITY

After intense deliberations the Municipal residents prioritized the following projects to be implemented in the next financial year:

- Constructing of a Non- Motorized Transport (NMT) facilities, priority be given to Las Jona – Posta – KCB – AI Road, Tamu Supermarket – Hospital – Police Station Road and Bearbelt – Posta Road.
- Opening up and upgrading to bitumen standards all the blocked access roads within the municipality. A priority be given to the backstreet road for opening and upgrading.
- Completion and operationalization of the modern bus park, installation of waste bin, installation of powers supply meters within the kiosks, operationalization of the ablution block and opening of the exit.
- Renovation of the modern market shade, paving of the access routes, renovation of the washrooms, construction of the market waste holding pit and renovation of the market stalls/shops.

After prioritization session of the proposed projects by the municipality residents, the municipal board chairperson thanked all the residents for attending this important meeting. He further urged the residents to join hands in every development initiative commenced in the municipality for the sake of success and public good. The meeting was then closed by a word of prayer from Mr. Tom Okeyo at exactly 1.32 pm.
